AHP's commitment to accomplish and maintain a successful Environment, Health, and Safety Management System is achieved through the following actions.

- Establishing EHSMS Systems and provide adequate human and financial resources to effectively develop, implement and monitor the implementation of the Abu Dhabi EHSMS in AHP.
- Conducting a situational analysis, EHS management system reviews and epidemiological surveys and studies in order to assess environmental and occupational health and safety hazards and risks resulting from operations of AHP Activities.
- Eliminating or reducing to a level ALARP "as low as reasonably practicable" any significant environmental and occupational health and safety risks for clients, employees, visitors and all stakeholders.
- Strengthening the AHP EHSMS in all Departments and developing the necessary system tools.
- Promotion and enforcement of environmental protection and sustainable management, occupational health and safety and infection control through targeted initiatives, campaigns and training activities.
- Establishment and development of administrative and IT systems and support services for delivering on the AHP of ADHSMS EHSMS requirements, including registration, monitoring and reporting requirements.
- Development and dissemination of AHP EHSMS policies and standards based on scientific risk assessments, regulatory requirements and best international practice; and Coordination and collaboration with HAAD, Abu Dhabi EHS Center and relevant stakeholders in EHSMS related activities and services; AD EHSMS RF – Version 2.0 –Feb 2012 Health Sector EHSMS Requirements.
- Selecting the best consultants to facilitate the achievement of the above mentioned targets.
- Ensure Accountability is established to meet this policy.
- Comply with all applicable local, federal and International Environment, Health, and Safety Laws, Regulations, Standards and Best Practices.
